4. Online bids shall be opened in the presence of bidder representative who choose to attend on 2022-10-23 13:00 Hrs. at the office of Rural Municipal Executive, Khasyauli, Palpa. Online bid must be valid security for a period of 90 days counting after the day of bid opening and must be accompanied by bid security , which shall be valid for minimum 30 days beyond the bid validity period .The scan copy of bid security should be uploaded in the e-GP system during bid submission.
